<b>Category 1. All Risk Items – portable/valuable items e.g.</b> audio/visual equipment, computer equipment including laptops, domestic appliances/kitchen equipment, games consoles, mobile phones, pagers, office machinery, photographic equipment, stage lights and sound/PA equipment, <b>speed guns</b> , vending and gaming machines, CCTV equipment, antique furniture, civic regalia, cups, trophies, musical instruments, paintings, works of art, books, games, toys, stock, models, non-mobile plant, trailers, tools, bicycles, boats, caravans, shop mobility wheelchairs, christmas decorations, <b>defibrillators</b> , gardening equipment (including power tools) contents in a building (chairs, tables etc) (this is not an exhaustive list)
<b>Category 2. Municipal Infrastructure e.g.</b> playing surfaces, playground equipment, outside gym equipment, skate park equipment, sports courts & associated equipment, <b>bus shelters</b> , bus stops, , flagpoles, garden furniture/market stalls, gardening equipment (including power tools), <b>noticeboards</b> , signposts, <b>name signs</b> , <b>plant-holders</b> , plate glass/shop front signs, portacabins, portaloos, <b>public seats &amp; benches</b> , <b>refuse bins</b> , floodlights, <b>external lighting (including street lighting)</b> , surveying equipment, <b>telephone boxes (being used libraries</b> , noticeboards etc.), walls, fences, ornamental gates, weather appliances, memorials, statues, monuments,
